

SAID TRACT OF LAND CONTAINS A TOTAL AREA OF 2,603,798 SQUARE FEET OR 59.775 ACRES, MORE OR LESS, OF WHICH 48,418 SQUARE FEET OR 1.112 ACRES ARE CONTAINED IN THE RIGHT-OF-WAY OF NORTH 108TH STREET, OF WHICH 30,402 SQUARE FEET OR 0.698 ACRES ARE CONTAINED IN THE RIGHT-OF-WAY OF THE "UNKNOWN STREET" DEDICATED IN BOOK 439, PAGE 533. THEREFORE, SAID TRACT OF LAND, EXCLUDING SAID RIGHT OF WAY, HAS AN AREA OF 2,524,978 SQUARE FEET OR 57.966 ACRES, MORE OR LESS.
